5 WHEREAS, on April 4, 2022, the Court filed its Order Concerning Plaintiff’s Motions: (1) for
6 Final Approval of Class Action Settlement and (2) for Attorneys’ Fees, Costs, and Class Representative
7 Service Awards (the “Final Approval Order”), granting such motions;
